## PETER EBERL

**DEPUTY HEAD OF UNIT CYBERSECURITY AND DIGITAL PRIVACY, DG CNECT, EUROPEAN COMMISSION**

Peter Eberl is Deputy Head of Unit for Cybersecurity and Digital Privacy Policy in the European Commission's DG CONNECT. He works on the legislative negotiations of the ePrivacy Regulation, the implementation of the ePrivacy Directive and the implementation and evaluation of the Network and Information Systems Directive (NIS), and on other cybersecurity and privacy issues.

Since the beginning of the Covid-19 crisis, Peter has worked intensely on the European Union's common approach to contact tracing and warning apps, including the Commission Recommendation, the Commission Guidance, the EU Toolbox and cross-border interoperability of national apps.

Before moving to cybersecurity and privacy, he successfully negotiated the services part of the European Electronic Communications Code (EECC) and the net neutrality provisions in the Telecoms Single Market Regulation and the related BEREC net neutrality guidelines. Previously, Peter worked in DG Competition and in the private sector.



## ATHANASIOS DROUGKAS

**NETWORK AND INFORMATION SECURITY EXPERT, EU AGENCY FOR CYBERSECURITY (ENISA)**

Dr. Athanasios Drougkas is a Network and Information Security Expert at ENISA. His domains of activity in ENISA currently include cybersecurity in the Maritime and eHealth sectors, Cyber Insurance and the Digital Single Market and NIS industry.

In the past he has held various positions within the ICT industry, including Project Management, Presales, R&D and Technical Consulting.

Dr. Drougkas holds a BSc./MSc. in Electrical and Computer Engineering and a Ph.D. in Telecommunications from the National Technical University of Athens.



## PAUL GARASSUS

### PRESIDENT, UEHP - EUROPEAN UNION OF PRIVATE HOSPITALS

Paul Garassus (Neurologist, MD) President of the UEHP, Vice President SFES (French Health Economics Society) and President of the Scientific Council of BAQIMEHP (BAQIMEHP professional formation and analysis for the private sector of French hospitalisation) represents Private Sector at European level since 2008. UEHP supports development of certified private hospitals in contract with national Social Insurance, for innovation and sustainable health systems in EU28.
