Companies input their orders and sales every quarter, and they receive back their own **market share**, and the total size of the market.

Possibility of introducing new reporting segments, with a minimum requirement of three participating Companies.

Reports comprise all main medical imaging modalities: CT, MRI, MI PET CT, MI SPECT, Ultrasound and X-Ray

Reporting activities start in April for Q1 data, and end the following January for Q4 data.

Our reporting fees start from EUR 50 000 per year.
